INSTRUCTIONS FOR FILING CERTIFICATE OF CONVERSION/ DOMESTICATION

SUBMIT THE DOCUMENTS WITHOUT THIS PAGE

Note: All documents filed by the Secretary of State's office are considered public record and may be viewable online.

How to complete the Certificate of Conversion/Domestication:

Each of the numbered instructions below corresponds to a section on the form.

- List the entity's ID number issued by the Kansas Secretary of State (This is not a tax ID number). ID numbers may be found at https://www.sos.ks.gov/eforms/BusinessEntity/Search. aspx. If the business entity is a foreign (non-Kansas) business and has not filed a foreign application prior to the conversion/ domestication with the Kansas Secretary of State's Office, leave this field blank.
- 2. Provide the complete legal business name prior to the conversion/domestication, including words of formation (e.g., LLC, Inc., etc.)
- 3. Select the business entity type prior to the conversion/ domestication.
- 4. Provide the business's current domestic state prior to the conversion/domestication (e.g., Kansas, Missouri, etc.)
- 5. Provide the complete business name after the conversion/ domestication, including words of formation (e.g., LLC, Inc., etc.)
- 6. Select the business type after the conversion/domestication.
- 7. For the date the certificate will take effect with the Secretary of State's Office, select either upon filing or select future effective date and provide a date the certificate will take effect. This date may not be greater than 90 days from the date the Secretary of State's Office files the certificate.
- 8. Prior to submission, the certificate must be signed by an authorized person on behalf of the business resulting from the conversion/domestication.

Once the steps are completed, attach the appropriate formation document associated with the business type in section 6 with the filing fees.

Fee Schedule

Conversion/Domestication + Formation Documents

The total filing fees are listed below for both the formation document and the Certificate of Conversion/Domestication (Form CDD). Clicking on the formation document's name will navigate to the form for the formation document listed.
